<b>78</b>	<b>Questions and comments from residents</b>
	<p>A resident spoke in relation to agenda item 81. The resident expressed concern about the proposed double-yellow lines and did not feel that the necessary criteria for their introduction had been met, namely:</p> <ul style="list-style-type: none"><li>• genuine safety concerns;</li><li>• evidence of regular damage only accidents;</li><li>• three or more accidents during the last five years which have resulted in injury;</li><li>• an existing parking problem causing congestion issues to major routes.</li></ul>
<b>79</b>	<b>Apologies for absence</b>
	<p>The Committee received apologies for absence from Cllrs Davies (personal) and Samuel (business) and <b>RESOLVED</b> to accept the reasons for absence.</p>
<b>80</b>	<b>Declarations of Interest</b>
	<p>No declarations of pecuniary and/or non-pecuniary interests were received.</p>
<b>81</b>	<b>Highways proposal to introduce a new prohibition of waiting order on Quarry Road</b>
	<p>The Committee considered the proposed prohibition of waiting order. It was noted that Highways had confirmed that it had been requested to consider the introduction of formal parking restrictions at this location as it had been noted that since the implementation of the one-way system vehicles had been observed parking within the area resulting in a danger to cyclists who are permitted to travel against the one-way on a contra-flow basis.</p> <p>The Committee agreed to respond to the Highways Engineer asking him to:</p> <ul style="list-style-type: none"><li>• confirm how the proposed prohibition of waiting on Quarry Road meets the four criteria as stated by the resident (minute 78);</li><li>• clarify why double-yellow lines are proposed on an experimental road layout;</li><li>• provide an up-to-date location map.</li></ul> <p>It was agreed that the matter would be considered further by the Committee once a full response had been received from Highways.</p>
