a	<u>Four Winds, Liverpool Road, Neston CH64 3RF</u> The Committee reviewed planning application 23/03841/FUL (demolition of existing bungalow, proposed new five-bedroom house, wall and gate with detached garage) and <b>RESOLVED</b> to submit the following comment to the Planning Authority: Neston Town Council recognises that the revised plan has taken into account issues raised previously. The Town Council is, however, still concerned that the proposed property is out of proportion and character and is overbearing. It is also concerned about the height and appearance of the outer wall which is not in keeping with other properties in road.
b	<u>Red Lion, The Parade, Parkgate CH64 6SB</u> The Committee reviewed planning application 23/03932/FUL (change of use of part of first floor accommodation to trading area. Infill small balcony to form extension of first floor internal area with new sash window to match existing) and <b>RESOLVED</b> not to submit a comment to the Planning Authority.
c	<u>Overdale Farm, Hinderton Road, Neston CH64 9PW</u> The Committee reviewed planning application 23/03857/FUL (demolition of existing dwelling and erection of new detached dwelling with new access) and <b>RESOLVED</b> to submit the following comment to the Planning Authority: Neston Town Council is concerned about adding another access point onto Hinderton Road given the amount of traffic that uses this route.
